Former TV News anchor
and Author of
“Write Your Own Story.”**

PATTI ANN BROWNE is a former TV news anchor and current voiceover artist, author and occasional guest on TV shows and podcasts.

A news anchor for three decades, Patti Ann is best known for her seventeen years with Fox News Channel. She co-hosted a morning show with Ainsley Earhardt and others for almost two years, appeared nightly on Glenn Beck’s top-rated Fox News program for its entire run, and was a regular on the late-night talk show *Red Eye* with *Greg Gutfeld*.

Also a veteran of MSNBC and News 12 Long Island, Patti Ann is a Fordham University alum and has a master’s degree from the New York Institute of Technology. Having quit the news business in 2018, she does some voiceover work, speaking engagements, and volunteering, while enjoying life on Long Island with her husband and teenage son. Her recent memoir, *“Write Your Own Story: How I Took Control by Letting Go,”* briefly hit #1 on Amazon’s list of Bestselling Journalist Biographies.

Named one of the “Top 30 in Irish American Media” nationwide by *The Irish Voice*, Patti Ann is also the recipient of a Regional Associated Press Award for 1st Place Documentary Feature, a FOLIO Award, and the Dennis Puleston Award for Environmental Achievement. She was featured in *World of Hibernia* magazine as one of the “New New York Irish: Bright, Brave and Breaking New Boundaries in NYC.” A practicing Catholic, Patti Ann is in the Brooklyn Diocese Hall of Fame (which includes Queens, where she grew up).



EILEEN MARIE WHITE COMMUNITY AWARD

Honors an outstanding individual who brings their communities together to support those who need it most. Eileen Marie White was a passionate community advocate who fostered a culture of giving back. The award is presented annually to a woman who continues to honor the tradition of female leadership in community service.



BOJANA KUSIC

Bojana Kusic has been with Meta, Facebook's parent company, for over five years. Her role included overseeing the East Coast projects, with a primary focus on New York. Bojana's role was recently expanded to the Head of Facilities Projects for NORAM.

Bojana has been in the New York City construction industry for over 12 years. Prior to joining Meta, Bojana worked with Gardiner & Theobald, as well as WSP Global.

Bojana earned both MBA and a Bachelor of Science degrees from the University of Illinois at Chicago.

She also enjoys running in marathons.



FRANCIS J.P. MCHALE MEMORIAL AWARD

MICHAEL PROHASKA

Mike Prohaska has been a member of the Laborers International Union of North America (LiUNA) for over 45 years and is Business Manager of the Mason Tenders District Council and Construction and General Building Laborers' Local 79. Mike represents 17,000 members in one of the nation's most progressive and aggressive labor organizations of construction workers, hazardous materials handlers, Catholic High School teachers, and recycling and waste handlers. Through collective bargaining agreements, LiUNA enables workers to earn middle class wages, good benefits, and opportunities for advancement and better lives.

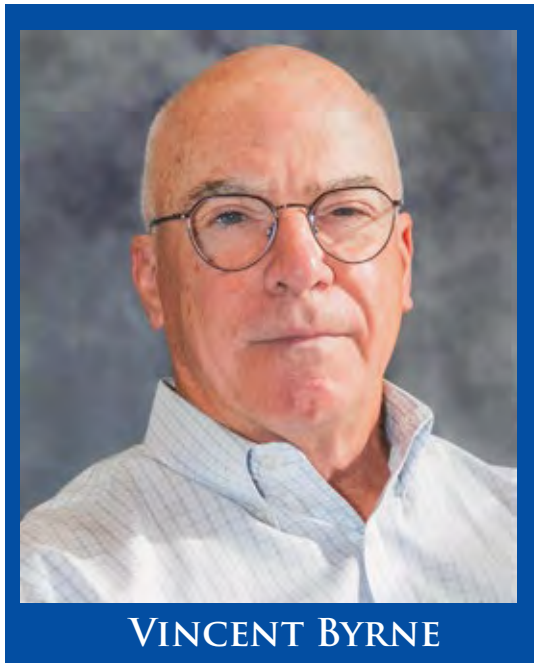
Bronx born and raised, Mike began his career as a rank-and-file laborer and has gone on to serve in numerous leadership roles in LiUNA. In 1995, during the historic consolidation and re-structuring of the Mason Tenders District Council and its affiliated unions, he was tapped by the International Union as part of the next generation of leaders. Following success with the 1995 asbestos and hazardous waste organizing campaign and the 1996 demolition workers' campaign, Mike was appointed Director of Organizing for the newly chartered Construction & General Laborers #39; Local 79, the largest Laborer's local in the country. He began his career as an elected officer of the Local in 1996, serving in several capacities: sergeant-at-arms; vice president; recording secretary; and, business manager, the position he currently holds. Mike is secretary-treasurer of the MTDC PAC and a trustee for the Mason Tenders Trust Funds and the New York State Laborers Tri-Funds.

Mike is a firm believer that it is through education and training that workers can advance. He has attended the Cornell University School of Industrial and Labor Relations, the New York State AFL-CIO/Cornell Union Leadership Institute, and the National Labor College, formerly the George Meany Center for Labor Studies. Mike proudly serves on the Board of Directors for Nontraditional Employment for Women, a pre-apprenticeship program that trains women for careers in a skilled construction trade.



VICTORY AWARD

VINCENT BYRNE

Upon graduating from college in the early 1970's J. Vincent (Vinny) Byrne spent eight years overseeing construction of mechanical systems for large-scale commercial developments with a nationally prominent mechanical contracting firm where Vincent found his project viewpoint drew upon a real-world approach to design and project management that few consultants could match. In 1985, Vinny joined Robert Director Associates as a designer/draftsman. 28 years later Vinny gave up managing projects and people to pursue Business Development on a full time basis.

RDA has a long history of supporting the Friends of St. Dominic's and in 2013 Eugene White asked Vinny to be on the dinner committee. Being a committee member resulted in visiting the Blauvelt facilities a number of times. It was during these site visits he realized the impact the Friends of St. Dominic's has on the people being served. Being involved for the past 10 years has been an extremely rewarding experience.
